

HKRU TERTIARY TEAM DEVELOPMENT GRANT & SUBVENTION
AGREEMENT

This Agreement is made on 12th September 2018

BETWEEN: HONG KONG RUGBY UNION (HKRU)
Room 2001, Olympic House, 1 Stadium Path, So Kon Po, Causeway Bay,
Hong Kong.

AND:

1. AGREEMENT CONTROL

The agreement shall be subject to the direction and supervision of the HKRU as required. Officers of the HKRU shall be nominated to act as representatives to liaise with the Team for all matters relating to the Agreement.

2. AGREEMENT PERIOD & RESPONSIBILITIES

The period of the Agreement will be on a continuous basis commencing from 1st September 2018 and concluding 31st August 2019 or as directed by the HKRU.

3. PAYMENTS

(a) Terms of Payment

The Team will receive a one off subvention of **HK\$12,000.00** for the season, commencing from September 2018 to June 2019 inclusive, on satisfactory completion of all requirements of this Agreement.

(b) The HKRU will also provide Teams with equipment for the playing and coaching of the game of rugby and Teams will be expected to make all reasonable efforts to maintain the equipment in good repair.

(c) The payment will be provided for the Institutes future development or current financial support. The payment will be given before June of 2019.

4. PRIVACY AND CONFIDENTIALITY

The terms of this Agreement shall remain private and confidential as between the Team and the HKRU and both parties shall observe privacy and confidentiality as to these terms and any information relating to the Agreement. No information shall be communicated to the media or other outside parties except under such conditions as the HKRU and the Team may agree beforehand.

5. TERMINATION AND VARIATIONS

Should the Team fail to comply with the provisions outlined above or fail to carry out any of the obligations or duties required of them under the terms of the Agreement, the HKRU may, reduce the amount of subvention or if necessary, terminate the agreement.

6. TEAM DUTIES & RESPONSIBILITIES

The Team agrees to carry out the following duties in consultation and to a standard agreed by the HKRU;

No	Item
1.	Ensure effective dissemination of Union communications to relevant Team members.
2.	Ensure all Team players and coaches are registered correctly with the HKRU using the HKRU's new online registration system.
3.	To encourage the attendance of Team members at coaching and refereeing courses.
4.	To encourage the Team and its member's to participate and support any Three (3) of Four (4) HKRU Tertiary events: 1. HKRU Tertiary Rugby Beach Tournament 2. HKRU Tertiary Rugby Sevens Tournament 3. HKRU Tertiary Rugby Invitational Sevens Tournament 4. HK Touch Association Tertiary Rugby Touch Championship
5.	To ensure training equipment, supplied by the HKRU is maintained and stored correctly.
6.	Teams are to ensure that the Chairman (or representative) and/or other representatives as necessary attend monthly Tertiary committee meetings and /or other HKRU Meetings.

7. MEDIA & IMAGE RIGHTS

The Team agrees to work with the HKRU in it's efforts to broaden the appeal and development of rugby in Hong Kong by delivering a positive media message regarding all Tertiary Rugby and HKRU activities and as such should not issue negative statements to the Press. Teams should address any such issues through the official channels of the HKRU. The Team agrees to allow the HKRU to use images of their players for the purpose of the promotion of the game of rugby.
